## NOTICE OF PROPOSED TAX INCREASE Central Utah Water Conservancy District IN SALT LAKE COUNTY

The Central Utah Water Conservancy District is proposing to increase its property tax revenue.

- -The Central Utah Water Conservancy District tax on a \$388,000 residence would increase from \$81.52 to \$85.36, which is \$3.84 per year.
- -The Central Utah Water Conservancy District tax on a \$388,000 business would increase from \$148.22 to \$155.20, which is \$6.98 per year.
- -If the proposed budget is approved, Central Utah Water Conservancy District would increase its property tax budgeted revenue by 5.62% above last year's property tax budgeted revenue excluding new growth.

All concerned citizens are invited to a public hearing on the tax increase.
