Guidelines

- All proceedings will be recorded and shared publicly. You can find them posted on our website <https://cuwcd.com/board.html> and the Utah Public Notice Website within three business days
- Per security protocol, all electronic participants will only have audio capabilities
- Microphones for public speakers will be wiped down after each presenter
- Chairs will be set up using social distancing measures
- Masks are required for public attendees (and will be available)
- Hand sanitizer and sanitizing wipes are available
- Disruptive behavior that distracts from the meeting will not be tolerated. Those individuals will be asked to leave, so that the Board may continue to hear from the public and fulfill the duties they have been assigned
